Dear Shareholder, Unit Owner and Tenant,

Argo Real Estate, as agent for the building owner or condominium association, offers a payment program, ACH Debit, enabling you to have your monthly maintenance/common charges/rent paid directly from your bank account at no additional cost.

Enrollment in the program will ensure payment of your monthly charges even if you are traveling or away for an extended period of time. It will guarantee that no late fees will be assessed on your account as long as the funds are available.

Enrollment

To enroll, you must sign and return the enclosed authorization agreement along with an original, voided check from a checking account to pay your monthly charges. We must have a voided check to obtain the routing number of your bank as well as your account number. Please remit all required documents to my attention at the address above. Written notification of your participation in the program will appear on your monthly invoice. If your monthly statement does not indicate your enrollment in the program, you must remit payment by check.

How it works

Each month you will receive an invoice for your monthly charges, the same as now. The amount due will automatically be deducted from the account you specified anytime between the 1st and 5th business day of each month. The total amount will include base charges, electric, garage, and any other charge imposed by your building. If funds are not available at the time your account is debited, you will be billed back the monthly charges, including a bank fee. This is the same procedure as if a check was returned. We will notify you promptly of insufficient funds and request payment by check or money order to cover all outstanding charges.

This program is optional but we hope you will take advantage of the convenience this program will afford you. Please feel free to call if you have any questions.
